Dear Senators Smith and Wyden,

I believe in a strong America. Strong in the sense of creating high-paying jobs, increasing standards of living, and economic world leadership. We can accomplish this by investing in America - to become *the* source for the future energy needs of the world. I also believe that we possess the resources and talents necessary to enable the United States to become a net-exporter of renewable energy.

Since the first oil shock in 1973, the net result of all our efforts is - we went from being 25% dependent on foreign oil to over 60% dependent today. And it is getting worse. In 1973, Denmark was 98% reliant on foreign oil. It was the "frog in the boiling water that jumped out." Now, it is a net-exporter of renewable energy. Why? Over the past 32 years, we - as a nation - *have not made the bold decisions nor marshaled the national resources required for such leadership* - to change the direction of our fossil fuel addiction. We have been the "frog in luke-warm water," and have remained there, while the temperature has been slowly raised to the boiling point!

This nation should commit itself to achieving the goal, within the next 20 years, of becoming a "net-exporter" of renewable energy. This goal is more impressive than a moonshot, certainly more useful than a "mission to Mars," and of more peaceful value than the Manhattan Project. Positioning the United States to become the ultimate controller of (renewable) energy will do more to create jobs, increase our security, reduce the need to go to war, enhance our economy while improving our environment - and will secure our future as *the* world economic leader - for decades to come.
